

**REQUEST FOR PROPOSALS FY 2025/2026:
Burke County Juvenile Crime Prevention Council (JCPC) & N.C. Dept. of Public
Safety Division of Juvenile Justice and Delinquency Prevention (DJJDP)**

Burke County JCPC requests from local non-profits, proposals to serve delinquent and at risk youth, ages 6 to 18 if under court supervision. Programs must have a SPEG service type, an "evidence based" model or a service requested by the DJJDP. Programs must have an evaluation component which can demonstrate impact on the risk factors below.

Approximately \$287,074 will be available [dependent on availability of funds] for July 1-June 30, Fiscal Year 2025/26. Local match of 30% required.

Deadline for applications: Wednesday, February 19, 2025 - 5:00 P.M.

Burke Co. priority risk and needs factors compatible with legislative mandates:

- Age at First Delinquent Offense Alleged in a Complaint
- Number of Referrals with a Result
- Felony Referrals
- Known use of Alcohol or Illegal Drugs by Youth or Family
- Serious School Behavior Problems
- Mental Health Needs
- Family/Juvenile Criminality
- Runaway/ Insecure Living Arrangement/ Inadequate Supervision
- Low Academic Performance/ School Attendance & Involvement
- Negative Peer Association
- History of Abuse or Victimization
- History of Aggression/ Violence/ Weapon Offence / or Person Crimes

Funding priority will go to following service types:

1. Restitution / Community Service
2. Substance Abuse Assessment and Treatment
3. Sex Offender Assessment and Treatment
4. Psychological Assessments
5. Teen Court
6. Interpersonal Skill Building
7. Parent / Family Skill Building
8. Mediation
9. Counseling
10. Vocational Skill Building
11. Temporary Shelter
12. Mentoring.

Programs are required to submit a copy of the following application attachments:

1. Management letter with a form stating "No Overdue Taxes are Due"
2. Conflict of Interest Statements
3. Proof of 501(c)(3) status
4. Current list of Board of Directors with addresses
5. Programs not funded at the time of the RFP deadline are required to submit three letters of support from outside their agency and their most recent annual audit or financial statement.

To apply, complete the online application by accessing NCALLIES through an NCID registration. Follow instructions at <https://cp.ncdjjdp.org/CP> for the program agreement application. New programs will need to complete NCID registration first.
